Make sure your name & address is clearly visible in a window, and your trailer battery **must be removed** to avoid freezing. Storage for the dates above is \$400. due before August 15, plus \$18.00 to move trailer into and out of storage building. An *Outdoor Storage* form is required for the months your trailer is not indoors (see fee below). Due to changes in local law - Trailers must display up-to-date/valid license plates. We cannot accept 5th Wheels for indoor storage.

**NOTE \*** This fee **does not** include moving the trailer into and out of the storage building. This fee is \$18.00. Please make this \$18.00 check payable to Chris Rogala.
